Re: H.R. 333: Disabled Veterans Tax Termination Act

Dear Congressman Bishop:

The National Military and Veterans Alliance, an organization composed of military associations and veterans organizations representing active duty, National Guard, Reserve, military retirees, veterans, families and survivors, writes to thank you for your leadership in addressing the issue of concurrent receipt for our disabled military retirees by sponsoring H.R. 333: The Disabled Veterans Tax Termination Act.

As you know, military retirement is earned by serving twenty or more years in the military, compensates for longevity of service, and is funded by the DoD. Disability pay is earned in connection with those years of service and compensates for pain and suffering, can be both combat and non-combat related, and is funded through the VA. Retirement is also earned when a disability causes a service member to be medically retired prior to reaching 20 years of service

Prior to 2004 all disabled military retirees were forced to comply with the offset. Since 2004 military retirees with 20 or more years of service and a disability rating of 50 percent or higher are allowed to receive both their military retirement pay and their VA disability compensation without the offset. However, current law does not eliminate the offset for those service-connected disabled military retirees with 20 or more years of service and with VA ratings of 40 percent and below or for Chapter 61 veterans who were medically retired prior to reaching 20 years of service. No other federal employees are penalized for retiring and having a disability.

The National Military and Veterans Alliance is committed to the notion that by not being allowed to receive both retired pay and VA compensation, a veteran who was wounded in combat or otherwise disabled as a result of his or her service but has a rating less than fifty percent is actually paying for being wounded or disabled out of his or her military retired pay.
